



## The Annual Meeting of Provincial Grand Court



The Annual Assembly of the Provincial Grand Court of Sussex took place on Saturday the 11<sup>th</sup> of April 2026 at the at the Chichester Masonic Hall, with R.W.Bro. Mark P Donovan, *GCAG*, Provincial Grand Master presiding.



Brethren started to arrive from 9 am and made their way to the bar where coffee, tea, and bacon rolls were being served. It was good to catch up with Brethren from around the Province. and further afield.

Attending were many members of the Province, plus guests from Grand Court and other Provinces, together with Distinguished Brethren from many parts of our own Province.

The Provincial Grand Marshal, W.Bro. Mickey Wiles, KAG, addressed the Brethren in the Temple and the Brethren were called to order to receive R.W.Bro. Brian Prevett, Past Provincial Grand Master. The Provincial Grand Masters and other Right Worshipful Brethren then entered in Procession.

The Provincial Grand Master accompanied by Provincial Officers of the Year then entered in Procession.

Provincial Grand Court was opened by the Provincial Grand Master who was saluted with seven under the direction of the Provincial Marshal, W.Bro. Mickey Wiles, *KAG*.

Provincial Grand Court then received the Grand Master, M.W.Bro. Charles Jonathan Aspinell, *GCAG*, accompanied by the Deputy Grand Master, R.W.Bro. Clive Manuel, *GCAG*, and the Assistant Grand Master, R.W.Bro. Lionel Mee, *GCAG*, who were warmly welcomed by the Provincial Grand Master.

The Grand Master was saluted with eleven under the direction of the Deputy

Grand Marshal, W.Bro. Steve Devlin. M.W.Bro. Charles said how good it was to be visiting the Province of Sussex, in the very Temple where he was Instructed all those years ago.

An In-Memoriam to honour departed Brethren was held. The Deputy Provincial Grand Master read the names of departed Brethren.

The Provincial Grand Master called upon the Provincial Grand Prior for Prayer and the Brethren stood while the Grand Organist quietly played the first verse of Abide With Me.

The Provincial Grand Master introduced and welcomed our honoured guests and visitors.

The Provincial Grand Master was then pleased to greet those Brethren who had been Instructed into the Order since our last Annual Meeting.



After the regular business of Provincial Grand Court had been concluded the Provincial Grand Master thanked W.Bro. Bernard Marchant, *KCAG, PSGD*, for his dedication and support over the year and was pleased to re-appoint him as Deputy Provincial Grand Master. W.Bro. Bernard was saluted with five under the direction of the Provincial Marshal and responded appropriately.

W & Em Bro. Chris Eley was thanked by the Provincial Grand Master and re-invested as the Provincial Prior. W.Bro. Satish Dhir, *KAG*, was appointed and invested as Provincial Senior Grand Warden and W Bro Varinder Dhir, *KAG*, as Provincial Junior Grand Warden. A total of 21 appointments and promotions were made.

The RW Provincial Grand Master then addressed Provincial Grand Court. *A copy of his Address is at the end of this article.* He said how good it was to see so many Brethren at the Annual Meeting and thanked everyone, members and guests, for coming.

The Grand Master addressed Provincial Grand Court:



*“Brethren, it’s a real pleasure to be back here in Sussex. This Province holds a special place in my heart, because it was here that I was first Instructed in our beautiful Order. I am genuinely proud to be a Sussex Athelstan member, and standing among you always feels a little like coming home.*

*I want to congratulate you on the tremendous progress you’ve made in growing your Courts and strengthening your membership. What you’ve achieved hasn’t happened by chance. It’s the result of enthusiasm, commitment, and a real enjoyment of your Athelstan Masonry, and that enjoyment shows. Your Courts are lively, your meetings are well supported, and the sense of fellowship here is something you can feel the moment you walk through the door.*

*As an invitational Order, we have a particular responsibility: to bring in Brethren who will truly appreciate what Athelstan offers; its history, its symbolism, its warmth, and its spirit. Sussex has shown that when we focus on quality, the Order grows naturally and in the right way.*

*So, I encourage each of you: keep enjoying your Athelstan Masonry. Attend your Courts, support your officers, and keep that spark of curiosity and friendship alive. After the collection of Alms, the Provincial Grand Master proposed donations of £250 to two charities, Chestnut Tree House Children’s Hospice for Sussex, and Guernsey Society for the Prevention of Cruelty to Animals. The proposition was seconded by the Deputy Provincial Grand Master and approved by the Brethren.

The Grand Master, Deputy Grand Master, and Assistant Grand Master retired from Provincial Grand Court. Provincial Grand Court was closed, and the RW Provincial Grand Master, the Deputy Provincial Grand Master, the W&Em Provincial Prior, and the Provincial Grand Wardens retired in procession, before returning for photographs with the Grand Master and his team.



The meeting was followed a pre-lunch drinks reception in the Chichester Masonic Hall after which the Brethren of the Province of Sussex and their guests enjoyed an excellent and convivial Festive Board.

For the first time at the Sussex Annual Meeting we have 95 in the temple and are dining over ninety brethren, which is fantastic and reflects that someone must be doing something correctly. NOT ME!

The last time I tried to say something complimentary about my Deputy, Bernard, in Guernsey my sore throat came back and stopped me, so I want to say it was very meaningful to reappoint him today and thank him for all his hard work and support he offers me always.
